### **Overview**

What are Malaysia's New solar PV guidelines?

The Guidelines introduce key changes to the existing framework, enhancing the scope and flexibility of solar PV installations. These changes aim to accelerate energy transition in Peninsular Malaysia and support the country's goal of achieving a 70% renewable energy capacity mix by 2050.

In addition to the above Nova programme, NEM Rakyat for general households and NEM GoMEn for government buildings are also being implemented.

On the flip side, the US tariffs succeeded in nudging some of the solar players in Malaysia to set up in the US. For instance, Jinko Solar has been operating a growing US plant since 2021, while JA Solar and Longi have expressed plans to manufacture in the US as well. Does Malaysia have a PV industry?

Having said that, despite US tariffs being imposed on Malaysia from 2018 to 2022, the Malaysian PV industry, along with that of its three Asean peers, has managed to grow, owing to the strong demand for the product. Almost all of the PV products manufactured in Malaysia — largely PV cells and modules (cells that have been assembled) — are exported.

Is Malaysia a good place to invest in solar energy?

Thanks to the various incentives and cost-reducing stimulus introduced in respect of solar and/or renewable energy, Malaysia has in the recent years



witnessed the rise in the solar energy industry with growing investor confidence.

What are the installation conditions of a solar photovoltaic system?

The installation conditions of the solar photovoltaic system are 85% or lower of the maximum power demand of the site, and a capacity of up to 1,000 kW can be installed. Category B: The excess electricity generated by the participant in the programme can be used to offset the cost of electricity at up to three designated sites.

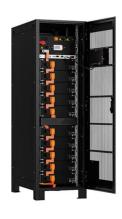

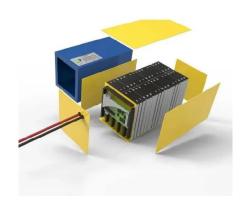
