

New requirements for energy storage exports in Spain





Overview

The Spanish government approved Royal Decree 7/2025 on June 24, resolving several long-standing obstacles hindering the secure and lawful deployment of energy storage projects. This move responds to the large-scale blackout incident experienced by the country in April this year. Why should Spain invest in energy storage?

Investing in energy storage helps Spain meet its climate goals. This includes achieving carbon neutrality by 2050. Storing renewable energy instead of wasting it helps the country rely less on fossil fuels. This also cuts down greenhouse gas emissions. Pumped hydro, thermal storage, and battery systems are effective technologies.

What is the European Commission's new energy storage support scheme?

The European Commission approved a new support scheme. It targets largescale energy storage projects in Spain. It focuses on technologies like standalone battery energy storage systems (BESS), pumped hydro energy storage (PHES), and thermal energy storage.

What does the energy storage package mean for the energy industry?

To promote the development of energy storage, the package proposes to speed up permits for projects, exempting them from the environmental assessment procedure if the facility is within the perimeter of a renewable plant that already has a positive environmental assessment. This is something the industry has been requesting for some time.






