

Polish grid energy storage policy





Overview

More than PLN 4 billion (\$1 billion) provided by the European Union's Modernization Fund will be distributed under the subsidy scheme by the end of 2025 in a bid to bring online more than 5 GWh of energy storage projects by 2028. What are Poland's energy storage subsidy programs?

Poland's 2024-2025 energy storage subsidy programs are a key element in the country's energy transition. With the growing demand for stable energy sources and the integration of renewables into the grid, energy storage facilities take on special importance.

What is Poland's energy storage program?

The program, "Electricity storage facilities and infrastructure for improving the stability of the Polish power grid," is aimed at companies planning to invest in energy storage facilities with a capacity of at least 2 MW and a minimum capacity of 4 MWh.

Why should Poland invest in energy storage?

Development of energy production and consumption forecasting systems. Energy storage subsidy programs support the transformation of Poland's electricity grid into a more flexible and resilient system. Investments in storage facilities enable better integration of RES, improve grid stability and enhance the country's energy security.

How will the energy storage program affect the electricity grid?

In 2025, the program will continue to support the stabilization of the electricity



grid. Energy storage facilities at prosumers help relieve the burden on the grid and improve the efficiency of RES installations, also affecting the benefits of other market participants.

Are subsidies available for energy storage facilities?

Subsidies are available for energy storage facilities, as long as they are integrated with the energy source being implemented as part of the investment. The program provides support covering up to 20% of eligible costs. The continuation of both programs is planned with a larger budget.

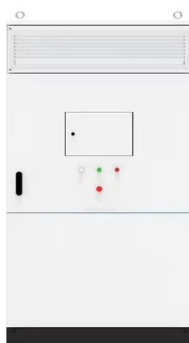
