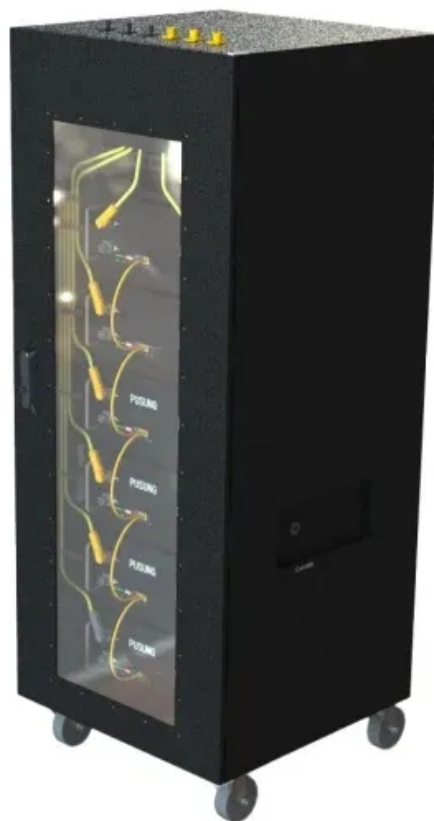

Overview

What are the requirements for installing a photovoltaic system in Spain?

The requirements for installing a photovoltaic system in Spain are as follows:
Obtaining administrative authorisation: In general, it is necessary to obtain administrative authorisation to install a photovoltaic system. The authorisation must be requested from the local council of the municipality where the system is to be installed.

Can I import a new item into Spain?

Avoid: Importing new items, even if they are for personal use. Customs officers can check all items being imported into Spain. If they think you're



importing new goods into the country intending to sell them, you'll have to pay the duty, VAT, and a hefty fine. Spain customs regulations provide several ways of requesting exemption from duty and VAT.

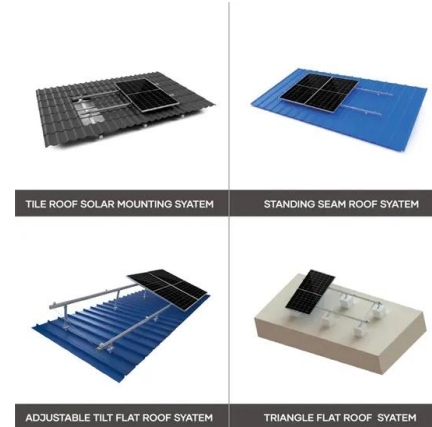

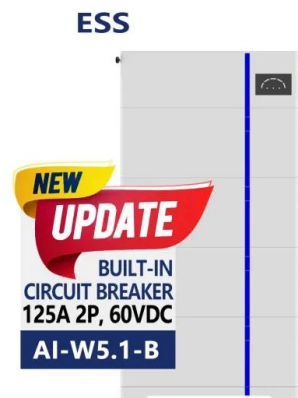

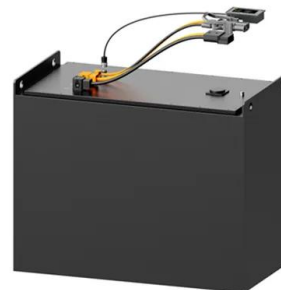
