Overview

What are the benefits of energy storage projects?

Energy storage projects will improve the reliability of transmission and distribution systems, especially in traditionally high-energy cost rural areas; more efficiently supply energy at peak periods of demand on the grid; and increase use of existing equipment, postponing or eliminating the need for costly upgrades.

What is included in the cost of a new wind or solar facility?
