

# United Arab Emirates Telecommunication Base Station Power Supply Construction Policy





### **Overview**

Who regulates the telecommunications sector in the UAE?

TDRA is the statutory body responsible for the regulation of the Telecommunications Sector in the UAE. TDRA regulates the sector according to its mandate: the Telecommunications Law – Federal Law by Decree No. (3) of 2003 Regarding the Organization of Telecommunications and its amendments and according to State Policy.

What is the telecommunications law in the UAE?

Makes the provision of unlicensed services punishable by fine or imprisonment Arabic language prevails, although the TDRA's website publishes an English translation of the Telecommunications Law and Regulations. The UAE currently has a policy of a duopoly market for public telecommunications services.

How to get a building permission for a telecom infrastructure project?

Based on the construction drawings the professional implementation of the inbuilding design manual will be assessed and the NOC issued. This forms the basis to obtain a building permission for the project (covering the part of the telecom infrastructure).

What are the requirements for a telecom room in a multi-tenant building?

Floor telecom room with minimum of 2m (W) x 1m (L) x 3m (H) spaces must be provided on all the floors of multi-tenant buildings (residential/commercial buildings) for the routing or splicing or termination of telecom cables.

What are the minimum specifications of a telecom cabinet?

The cabinet is specified to accommodate two telecom operator's requirements at the same time. The minimum specifications are as follows: Fibre terminal box fitted with 2 port of LC/APC adaptor & pigtails and with 2 port of SC/APC adaptor & pigtails for 4 core SM Fibre drop cable termination. 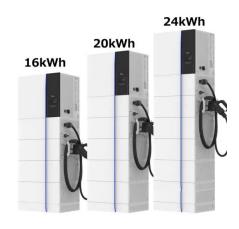

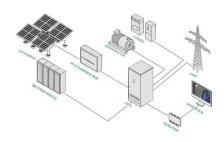
